**Extended Warranty Program for modular SB, SC and SD screwdriver product lines. This is an extension of the below standard warranty agreement.**

## **5 year warranty** on clutches in hand held tools.

Any warranty claim should be completed by an Authorized CP Warranty Service center. (excludes automation or machine mounted tools). This warranty is valid for SB, SC and SD series tools with a 2002 date code on the serial number.

## **4 year warranty** on complete tool for \$65/year.

Any warranty claim should be completed by an Authorized CP Warranty Service center. (excludes automation or machine mounted tools).

- 1 The extended warranty must be purchased with tool order \$65/year (eg for \$260 for 4 years)
- 1 The tool model number and serial number need to be logged with the CP Rock Hill Service Center before initial use in order to activate the warranty

### **Warranty**

North American Sales Company warrants to the original use purchaser that such products manufactured by Chicago Pneumatic, Desoutter, or Georges Renault shall be free from defects in materials and workmanship during normal use and proper service for a period of 12 months from the date of shipment from NASC or its distributors, whichever is later. This warranty applies only to products purchased new from NASC or an authorized distributor. Additionally, this warranty does not apply to products which have been abused, misused, modified or repaired by someone other than NASC or an authorized repair center.

All products claimed defective must be promptly returned (freight prepaid) to North American Sales Company or an authorized warranty repair center with adequate proof of purchase and description of the defect. All products found defective upon examination shall be repaired, or replaced at no charge. Repairs or replacements are warranted as described above for the remainder of the original warranty period. NASC's sole liability under this warranty is limited to repair or replacement of defective product. If the operation of the product is found to be due to abnormal use or improper service (including unauthorized modification or parts usage), such repair shall be performed by NASC at normal service charges to the customer.

NASC provides no warranty with respect to any product not manufactured by Chicago Pneumatic, Desoutter, or Georges Renault. As to such products, the purchaser shall be entitled to proceed only upon the terms of that particular manufacturer's warranty. NASC warranty does not apply to defects in material provided by the purchaser or to design stipulated by the purchaser.

NASC maximum liability shall not in any case exceed the contract price for the products claimed to be defective or unsuitable.
